Background Info

Medicaid is a lifeline for coverage and a foundational source of economic and health security for 80 million people. Yet, congressional Republicans plan to make massive cuts to our health care and Medicaid – as much as \$2.3 trillion in cuts – to pay for tax cuts for billionaires. Any of the changes being proposed will put stress on state budgets and lead to people losing access to this lifesaving comprehensive health coverage. North Carolina recently expanded our Medicaid program through bipartisan legislative action, so both sides of the aisle understand the importance of this health coverage to people in every corner of our state, especially our rural areas.

Topline Points

Medicaid cuts would:

- Take health care coverage away from millions of people, including children, people in nursing homes and those living with a disability and chronic illness;
- Make it harder for part-time workers with inconsistent hours, caregivers, and mothers to get health care;

- Increase health care costs for everyone, including medical debt for millions; and
 - Destabilize hospitals and health care systems that we all rely on, especially in rural communities.

Hello.

In North Carolina, we have around 3 million people who rely on Medicaid, including over 1 million children. Over the last year, over 614,000 North Carolinians have been able to get comprehensive, life-changing coverage through Medicaid expansion, a bi-partisan effort that we should be proud of and protect. Medicaid is a popular program that plays a significant role in local and state economies by keeping rural hospitals open, supporting job growth, and ultimately saving taxpayer dollars.

Will [Representative OR Senator] [Last Name] vote "no" on cuts to Medicaid and other programs to make sure your constituents can stay healthy and get the care they need, when they need it?

Thank you for your support for Medicaid and the thousands of people like [me or my family across our state who rely on this coverage to access care. I appreciate you taking this call and any actions you can take to protect Medicaid and other vital programs from cuts going forward.

[IF NOT SURE/NONCOMMITAL] Ask them what factors they are considering when thinking about the budget reconciliation process? What are their priorities? When do they expect to make a decision about whether or not they will vote to protect Medicaid?

I appreciate your time and consideration. Thank you for taking this call and for any actions you can take to protect vital health care programs from cuts. I will follow up with your office to check on the status of this request. [Be sure to follow up with them]

[IF NO]: Ask them for specifics about how they reached their decision. Take notes. This information can be used later for accountability actions.
