Stories from families across North Carolina about the critical need to protect Medicaid

Dear Lawmaker,

We are a coalition of organizations who represent thousands of North Carolinians across all 100 counties of the state.

The stories in this book will show you the critical role that Medicaid plays for families and communities in North Carolina. Access to affordable health insurance through Medicaid is crucial for seniors, children, families with low incomes, pregnant women, and people with disabilities. In 2023, we passed Medicaid expansion with broad bipartisan support, and it has been one of the most significant and impactful pieces of legislation in recent memory. In a little over a year, over 630,000 North Carolinians enrolled in Medicaid expansion, demonstrating the widespread need for this program. We are asking that you honor this legacy and preserve this achievement by protecting Medicaid.

The funding cuts being proposed at the federal level would disrupt care in all communities across the state. Medicaid provides affordable coverage to 1 in 4 North Carolinians and 24% of all North Carolinians who rely on Medicaid live in rural counties. Cutting or rolling back Medicaid coverage would shift the cost of Medicaid onto our state budget, potentially forcing cuts to other critical programs like schools and public safety while also increasing state taxes. Medicaid supports our businesses, workforce, and economy—and must be protected!

In addition, Medicaid is critical for our rural communities—and not just for those who use the insurance program. Medicaid expansion has brought much needed dollars to rural hospitals who were struggling financially, which helps to attract and retain health care workers as well. In most cases, these hospitals are the top employer in their area, so losing any of this funding could negatively impact the whole community, including leading to the hospital closing. Rural communities also face greater health care challenges with higher rates of chronic disease, tighter hospital budgets, and provider shortages. Medicaid cuts would only exacerbate these issues, leaving rural communities with more sick people and fewer options for care. On top of all this, Medicaid is a popular program supported by voters across the political spectrum. We are all stronger and healthier when everyone has access to the care they need.

"I am 41 years old and I live in Burlington, North Carolina in Alamance county. I am originally from New York, the Hudson Valley to be exact. My family and I moved to Alamance County back in 2016. I'm married to a very hard-working man named Tim and we have four awesome kids! Liam who is 18, Joseph who is 11, Emma who is 8 & Frankie Jane who is almost 6! Our 11-year-old son Joseph, has a dual diagnosis. He was diagnosed with ADHD and DMDD around the age of seven. If you are not familiar with DMDD it is an explosive behavior disorder that stems from depression and anxiety. This disorder comes with a medicine regimen & often is misunderstood. DMDD is a diagnosis that also affects the child's entire family. It makes it very difficult for the child to make and keep friends as they have a tough time with interpersonal relationships. Joseph has escalations that could typically last an hour or more. And when he is escalated, it is hard for him to become de-escalated. Joseph is a bright, kind AWESOME kid & just wishes more people understood his disorder.

For many years, even prior to his dual diagnosis he was in therapy. Due to us having private insurance, we were paying upwards of \$200 per week for co-pays for everyone in my family who was in talk therapy. \$200 a week in co-pays is really not sustainable for anyone who is working class or poor. Along with talk therapy Joe was also recommended for intensive inhome therapy. Unfortunately, due to us having private insurance we could not access that resource for Joe and for the health of our entire family. For five long years we dealt with not being able to access intensive in-home therapy. I do believe that this set Joseph's remission back many years.

At the beginning of 2024 my husband lost his employment. We were then finally able to apply for Medicaid. Intern we were then able to access intensive in-home therapies for Joseph. So far Joseph has made amazing progress, he is learning tools to help him cope with his disorder. My entire family could not be more thankful & grateful for being able to access this REQUIRED mental health service. I personally believe that health coverage is a right as American citizens, not a privilege of the wealthy. North Carolinians deserve to be covered under Medicaid. YOUR Constituents and neighbors urge you to ultimately oppose any bill that threatens to cut, restrict or cease Medicaid coverage for the over 1 million people you

represent. Thank you so much for taking the time to read this and I hope you make the right decision for your fellow North Carolinians!"



Jenifer has serious health complications, including a brain injury. She had been denied for disability SSDI multiple times between 2020-2023, and she desperately needed affordable health care. She was relieved when Medicaid expanded, after being without insurance for 3 or 4 months after being divorced. She hopes that she won't need to be on it for her whole life, but it's needed at this time.

Her adult children are now also enrolled in NC Medicaid, who both have health problems and work full time. Jenifer has had three previous heart attacks, and recently she went to the ER because her hand was numb. A scan detected a tumor in her head. She's seeing a specialist in Winston Salem now, and fortunately her care is covered by NC Medicaid through the expansion.

When Henry's aging parents became sick and needed help, he had to leave his bluecollar job to become their sole caretaker. Losing his income and then his health insurance left Henry with very few options for medical treatment and, like so many, he



delayed critical care, which impacted his quality of life and well-being.

Henry found out he was eligible for Medicaid expansion at Agape Health Services, a community health center, where he sought care for a dental issue. After not having insurance for years, being able to get health coverage has changed his life.

Thanks to Medicaid expansion, Henry regained access to vital healthcare services, including routine check-ups and medications. This gave him the support and peace of mind he needed to care for his parents without sacrificing his own health. His story highlights the life-changing impact of expanded healthcare access for hardworking individuals and families. "I can't and don't want to imagine what my life and my parents' life would be without this Medicaid help. It has made such a difference in how I feel and how I am able to give them the care they deserve. Thank you from the bottom of my heart."

"I had fallen and hurt my knee, and gone in for an x-ray. Coincidentally, the x-ray showed my hips and lower abdominal region as well. It also showed a golf ball sized mass in my abdomen. My orthopedist immediately sent me for a referral to a gynecological surgeon. I went for surgery within a month, and the tumor was already the size of a grapefruit, and had adhered to several organs. It was growing rapidly, and would have caused severe malformation to my kidney, bladder, and other organs had it not been removed. The surgery was more invasive than doctors had originally anticipated, and I had to stay in the hospital for several days. Recovery at home took weeks.

The only reason I was initially able to see a doctor was because I had Medicaid at the time. If I hadn't, I wouldn't have know about the tumor until it had grown exponentially, and become more of a threat to my life than it was. Because I had Medicaid coverage at the time, I was able to see a doctor, get a referral, seek treatment, and go on about my life. That x-ray was 26 years ago, and I've never forgotten how grateful I was to have coverage to see a doctor."

"I am a Black Mountain resident devastated by Helene. I'm very satisfied with being able to have Medicaid."

"All three of my children have been on Medicaid since they were born until a year ago. As a NC teacher, my children have always qualified for Medicaid until I hit year 12 on the salary schedule. Thank goodness they have, because I don't know how we ever would



have been able to afford giving birth, much less keeping our children healthy and whole. Raising three boys is no easy feat, but raising our children is the most precious gift in life.

Recently, WNC was devastated by Hurricane Helene. My husband has worked as a farm manager for the past 6+ years. During Helene, the farm he managed was almost completely washed away by Flat Creek and the Broad River. This has left him unemployed and our family is exceptionally burdened by medical costs. Medicaid is a lifeline, quite literally. We cannot afford to lose Medicaid."

Surrey is in her mid 50s and lives in Black Mountain, NC, along with her adult autistic son, Seth. She often talks about how life can change in an instant. Not that long ago, she had a comfortable life. Then, she was diagnosed with a rare and at



times truly debilitating triad of conditions: mast cell activation syndrome, Ehlers-Danlos syndrome, and dysautonomia. Suddenly, Surrey had to make trips to the Mayo Clinic and find multiple specialists closer to home.

As a result of the serious symptoms, she was no longer able to work, or some days even function. As her health declined, she was no longer able to work. Just as her income was dropping below the threshold for ACA subsidies, North Carolina's Medicaid expansion program went into effect. She often calls Medicaid expansion a blessing, as just one of her mast cell stabilizer medications costs about \$1,000 a month without insurance.

Too many people end up not seeking treatment because they can't afford it, their conditions get worse, and they end up in the ER, with a huge medical bill. I have been there. Please know that this health coverage doesn't just make a difference, it makes THE difference in people's lives. Health care is not a partisan issue. It is a human issue.

circus master, pizza maker, and in other roles around her community. But when her health began to decline, work became increasingly difficult. Through North Carolian's Medicaid expansion, Lori enrolled and was immediately able to see a primary care doctor. To her surprise, tests revealed two tumors, one of which was affecting her eyesight. She also has a growth around her optic nerve that, without Medicaid, wouldn't have been diagnosed until it was too late, and she lost her eyesight. "If I get cut off Medicaid now, I won't be able to get treatment. I'll just have to deal with whatever happens." Having Medicaid coverage has given Lori a fighting chance at managing her health without leaving her family in financial ruin.

This isn't the first time Medicaid has proven to be a vital lifeline for Lori. In 2024, she nearly lost a finger to an infection, and without coverage, she would have been forced to risk leaving it untreated. Instead, she was able to see a doctor, get antibiotics, and have surgery to save her finger. She knows that without Medicaid, she would be drowning in debt or might not have survived at all.



"I receive extra help thru Medicaid to pay my Medicare Part B cost. I think it is \$189 per month. If they stop my Social Security and Medicare, and Medicaid extra help, it will be devastating since my only income is social security."

Josh is a 33-year-old social, funny, and kindhearted person who has never met a stranger. He loves making people laugh and thrives in his community. But he also faces significant challenges due to Fragile X Syndrome and



moderate intellectual and developmental disabilities (I/DD). He relies on Medicaid's Innovations Waiver for in-home care, day supports, and other essential services that allow him to stay active and engaged. Despite difficulties, Josh's mom Laura expresses deep gratitude for the enormous positive impact Josh has had on her life.

"Medicaid provides a lifeline because nine out of ten times, people with disabilities have more medical needs that most of us wouldn't be able to afford,"" says Laura, Josh's mother and legal guardian.

Josh struggles with safety awareness, and his tendency to wander has been a constant concern for his family. In 2024, Laura requested a home security system through the Assistive Technology, Equipment, and Supplies (ATES) service to help ensure his safety. The system allows his family to track his movements and provide him with an alternative way to call for help in an emergency.

After months of persistent advocacy and negotiations the security system was provided, ensuring Josh's safety at home.

For Laura, this victory was about more than just a security system. It was about facilitating Josh's independence while keeping him safe. Medicaid also provides him with access to community programs, a gym membership, and other essential services that help him live a full life.

"Without Medicaid, we'd lose all his community-based services. It would be hard. I have to work, so this gives him an opportunity to go out and socialize with his own peers," she explains.

Laura has become a fierce advocate, challenging misconceptions about Medicaid and disability support. She knows firsthand that these services aren't luxuries—they are necessities.

"All Medicaid does is allow us the opportunity to give our children the ability to be a part of their community, be seen, be heard. And there's nothing wrong with that," she says.

With his mother's love, the support of his community, and the vital assistance of Medicaid, Josh continues to live a life filled with laughter and connection. Laura remains steadfast in her fight, not just for her son, but for all families navigating the same journey.

"Parents like me shouldn't have to fight so damn hard to make sure our kids are taken care of," she says. And yet, Laura makes it clear she will never stop fighting."

"As my husband and I prepare for our baby's arrival, we've been filled with both excitement and worry. Being hard workers, we've always done our best to provide, but the rising cost of healthcare had us wondering if we could afford the care we needed. That's when everything changed.

I'm most looking forward to knowing my baby will be well taken care of. With the coverage we have now, I don't have to worry about how to afford prenatal care. Having health coverage has been a lifeline—it's the peace of mind we didn't know we needed. It's

I'm so grateful for the support we've found. As we look ahead to the arrival of our baby, I feel relieved, knowing we're covered and that we can focus on what matters most: our growing family."

"Despite being hard workers, my family has been having a hard time keeping up with inflation and the rising costs of medical care. If it weren't for Medicaid we would have struggled to pay bills and delayed medical care or other necessities like we have in the past. Having coverage has made such a difference, we will now be able to make our rent payments. We are so grateful!"

"I got Medicaid because it's important for me and my 8 year old son to have medical insurance. I moved to NC in January and I am currently looking for work."

"I need help for my family. If I wasn't disabled I would still be working at least part time. I am presently in need of multiple surgeries in the near future as well as kidney failure. I have kidney disease and am quickly approaching kidney failure as per my blood work. I can't afford to have these surgeries and possible dialysis without the help of Medicaid."

"If I didn't have Medicaid I don't know what I would do! I have several doctors I go to and about 20 prescriptions that I rely on Medicaid to help me with. Thank God my copay is only \$4 each! I really pray that our Medicaid is not cut! It would literally kill me!"

"We live on Social Security paycheck to paycheck. My partner qualified for Medicaid due to low income and Cancer disability. If we lose Medicaid, we lose United Healthcare Dual Complete and lose healthcare completely. We could not afford any insurance otherwise and would probably go bankrupt."

"Young, low-income parents such as my daughter cannot afford health care. I have seen my daughter struggle with numerous health concerns and put them off at the expense of her health because she could not afford medical care and did not want to burden her dad and I even though we have offered. Once most moms in our county are no longer qualified for Medicaid, they do not have any health coverage."



"As a pediatric hospice nurse, children I care for on Medicaid are the only ones who consistently are able to receive life prolonging treatments in addition to the robust support hospice provided thanks to Concurrent Care. Without fully funded Medicaid, many medically complex children will not be able to receive the support they need most in their last months."

"I am gaining health insurance for the first time through Medicaid expansion. I am very excited to have vision services and dental care through Medicaid in addition to medical care. It's taken a huge weight off of me - it means more financial security for my family. I can now see a doctor when I get sick instead of having to delay or deny care."

Paying independent doctors fairly instead of a fraction of what hospital chains can bill for the same services will allow more competition to benefit patients and allow more decisions regarding health resources to be made in local communities where doctors live and work. Currently corporate executives in Charlotte or Atlanta decide where to offer clinics and hospital services rather than small town doctors somewhat in competition amongst local hospitals. Besides, funding Medicaid is a jobs program for rural America, keeping the small town offices and hospitals afloat."

"I am a lifelong resident of North Carolina. I currently reside in Franklin County where I have lived since 1994. I am reaching out to you today as a constituent who is extremely concerned about the proposed cuts to the Medicaid Program all over the country but especially here, in NC where we just passed a medicaid expansion bill not too long ago. I would like to share a story with you so that you might be able to put an actual person to the issue at hand.

I am a wife, a mother, a daughter, and a sister. I am a hard worker having been in the retail industry for many years. My husband is also an extremely hard worker and began his career in North Carolina working for our state. My husband also, like many of our neighbors, has battled with diabetes for many years. After being employed with the State of North Carolina for fifteen years and having some of the best health insurance, his employment ended. Only being offered gap insurance from Cobra at an outrageous price, he had no choice but to try and stretch his medicines to last as they could because the prices were not within our budget as we were trying to survive off of my income alone.

Thanksgiving Day, 2013 was to be an extremely joyful day as we had all of our family together for one day to give thanks as many Americans do. I noticed that my husband wasn't feeling very well because he only wanted a small plate with just a little turkey and a small spoon full of potatoes. That is absolutely uncommon because my husband is a very healthy eater and a pretty large guy. We carried on through the day and tried to keep going even though we knew he probably didn't feel like having company.

A few hours later after all of our extended family left, my husband had gone to the restroom and was yelling for me to come and help him. He had zero feeling or strength in either of his hands and that is when I made him allow me to take him to the emergency room. When we arrived at the emergency room the triage nurse took his blood with a glucose monitor that did not register his blood sugar levels because they were so high. A blood draw was needed and we were told his glucose levels were over one thousand. The nurse said she was shocked he made it to the hospital before having a cardiac event or falling into a diabetic coma. Afraid and confused, my husband was admitted and thinking about the financial consequences when he should have just been grateful he was getting care and he was alive!

The hospital stay was seven days and the staff was able to get his blood sugar levels under control and set up a plan for him to stay healthy after discharge. told my husband that he may actually qualify for emergency Medicaid that would help to treat his chronic illness until he was able to acquire insurance on his own. He did in fact qualify and we were able to get him healthy and not have to take on the medical debt that most definitely would have caused us to be destitute.

I am so thankful that Medicaid was an option and that it sustained my husband's medical needs until he found employment within the year. As working class people who have always done the right things, who fell on hard times, we can understand why Medicaid needs to be protected for all North Carolinians for any reason. I implore you to vote against any bill that restricts, cuts, or ends Medicaid coverage for the over I million people you represent here in our beautiful state."

"I am a physician who serves patients in Guilford and Rockingham counties. I have been fortunate to witness first hand the results of Medicaid Expansion in the rural areas of the state as well as the urban working poor. It has been



transformational to say the least. We have been able to provide better, more consistent care that has allowed North Carolinians to live more prosperous, healthy lives.

The patients who have benefited from Medicaid Expansion have been less anxious and so overwhelmingly thankful for the ability to obtain affordable healthcare. Taking this away—especially during this impending time of job losses—would be catastrophic to a large segment of the population."

"I got Medicaid through Medicaid Expansion coverage, very much needed since I am going through cancer treatment."

"I was paying \$100+/month for a Marketplace plan and I am now Medicaid expansion eligible. I'm starting a PhD program at UNC Chapel Hill in the fall and thought I would have to pay for student health insurance, so I am excited to save that money and about having dental and vision coverage."

"Medicaid allowed me to get my medicine after leaving my job. It means a lot to me and allowed me to figure out I had deeper heart problems. I wouldn't be here today without the coverage so Medicaid expansion is excellent! If you aren't working or don't have a job, there wouldn't have been anything to help you without it."

"Many of my closest loved ones are on Medicaid and they are so stressed about the possibility of losing it. They are all disabled and live in poverty because of their disability—post-polio syndrome, heart disease, CPTSD, severe hearing loss. I am asking you and the rest of Congress to stand up and do YOUR job—protect the constitution and care for all of your constituents."

"The Medicaid benefits would help with expenses, services and resources needed for my well being and mental health."

"I have a lot of friends and clients with disabilities, and their inability to work typical jobs should not disqualify them from traditional medical care. All their care, from check-ups to surgeries and prescriptions, is covered by Medicaid. A client with an intellectual disability here in Greensboro has been struggling with life-threatening epilepsy her whole life, and Medicaid covers her drugs and covered an implant that allows her to stop a grand mal seizure in its tracks. Without these treatments, she is isolated in her apartment, unable to access any resources."

"Without Medicaid I would be in the same situation." Tamika doesn't take for granted how much her life has transformed since Medicaid expanded in North Carolina. It often took two of her children to help her get to clinic



appointments before expansion. Her coverage now includes transportation to doctor appointments and physical therapy that has helped her with her mobility. With Medicaid, she can manage her diabetes, heart condition and diverticulitis and without going into debt.

"I can get all my prescriptions at the same time without asking for financial help from my children. The bill from a 5-day hospital visit when I was very ill with diverticulitis was all covered and I could afford the medicine I needed when discharged."

Tamika can do so much more since having full health coverage under Medicaid including enrolling in college for the first time at age 52. "If I didn't have Medicaid, I would not be doing this. Everyone wants to do better in life and not be stagnant. Now I can get the help that I needed to push me into the dreams that I wanted. I can do so much more than I could a few years ago. I can walk on my own and play with my grandchildren. I don't have a lot of pain." Tamika will be graduating in the spring of 2028 with a degree as a mental health counselor.

"My son has received in-home nursing care for the last three years through a CAP-C terminal illness waiver. He has severe obstructive sleep apnea, asthma, and a floppy airway, along with other medical concerns. Before we were granted nursing care and Medicaid, it was very dangerous for Javi to attend preschool, as he was still small enough to nap during the school day and required oxygen whenever he was asleep.

Every time he started to fall asleep at school, I would have to leave work and rush to pick him up or apply his oxygen and sit with him while he slept. Once Javi had a nurse to go to school with him, they were able to get him on oxygen should he fall asleep, monitor his vitals, and help him get through the school day safely.

I'm so grateful for Javi's wonderful nurses and the waiver that provides them. They have allowed me to continue to work and contribute to my community while ensuring my medically fragile son is safe, healthy, and able to learn and thrive with his peers."

"My 90-year-old mother is a longterm care resident of Emerald Health & Rehabilitation in Lillington, NC. She moved in May of 2022 after my siblings and I made the very difficult decision that it was not safe for her to



live at home any longer. She lived with my sister for 10 years, beginning when she started showing signs of dementia. For the last two of those 10 years, when my sister simply couldn't do it alone anymore due to the stress and difficulty it caused, my brother and I stepped in to assist in her care. Each of us rotated and cared for her in our homes. We did everything we could to avoid placing her in a nursing facility, trying to honor her wishes of not wanting to leave home.

After several falls and some tough conversations and once her dementia worsened, we made the most difficult decision of our lives to move her to Emerald. Since day one, her care there has been wonderful, and we are so grateful to the staff who are like family now.

My father was disabled starting in his late 40's due to heart issues and passed away at the age of 54 when I was 15 years old. My mother worked for decades in factories to provide for our family. She rarely missed a day of work. To this day, in her state of dementia, she will talk about having to go to work. I need to call her supervisor and tell him she won't be coming in today. She worries how she is going to pay the gas bill. She cries because she is worried I don't have lunch money or new shoes to start school. It's heartbreaking. My brother, sister or I go to visit her every single day in the nursing home. We are her advocates and are still devoted to her care, even though we can't provide it in our homes.

My mother deserves every penny she receives from Medicaid for her care. Again, she worked her entire life to provide for her family. She is not the 'parasite class' as Elon Musk once described people who receive assistance. The cost of her care at Emerald would be over \$136,000 a year if she had to pay out of pocket. There is no way she nor her family could afford this without Medicaid. It's simply not reality for most working class families."

"I live in Canton, North Carolina, a rural community outside of Asheville. I have custody of four of my grandchildren, ages 10, 12, 15, and 16, as their parents couldn't care for them due to addiction. Caring for my grandkids is an honor and a joy. They deserve the world, and I work hard to make sure they have everything they need to grow and thrive. But I'm trying to make ends meet on a fixed income, and it's never been easy. I work part-time, making \$8/hour to supplement my partial disability benefits. Especially as the cost of food and energy continues to rise, my family is barely making it. Sometimes I have to choose which bills to pay, or which essentials to cover. At times, I've had to skip refilling my prescription medications so my grandkids wouldn't have to skip meals.

I've heard politicians talk about cutting programs like Medicaid, which is the reason I can take my grandkids to the doctor. Any cuts to Medicaid would be nothing short of devastating for my family and millions of families like mine. They would mean kids go hungry, families skip doctor's appointments or ration medications, and our children's education suffers. Our overall economy, too, would be harmed.

I don't understand why any lawmaker would threaten programs that make it possible for families to survive – but it is truly appalling to know these cuts are designed to make it possible to cut taxes for billionaires and corporations. Every day, I wake up and figure out how I will make it all happen for my grandkids. At times, I've worked 6 days/week to be sure they and what they needed. All I'm asking is for our elected leaders to also put the needs of our country's most vulnerable children and families first."

For our kids, they mostly use it for preventative care, including wellness check-ups, vaccinations, dental cleanings, and vision screenings."

Her employer does not offer health insurance and she is covered by Medicaid expansion as of December 2023. She was accepted. Joanna has degenerative disc disease. She is scared for her nephew, his autism is severe and he's medically fragile. 10 years old."

And my mother, who has multiple health problems such as high blood pressure, severe diabetes, neuropathy, severe mental health problems, thyroid disease, etc., would simply die without the affordable health care that she receives."

We are a family of 5 and the children were the only ones that had Medicaid before expansion. My husband and I couldn't be happier to finally have health coverage."

When Dashita received her HIV diagnosis at sixteen, she was not only concerned with saving her life, but also with how to pay for her HIV medication because she knew the lifesaving treatment she



needed was expensive. Dashita knew that her family would not be able to afford the medication, blood work and doctor visits, and credits Medicaid in saving her life.

"I made a choice that I want to live, says Dashita." "Without Medicaid, I don't know what I would do," Dashita says. "I don't think that I would still be around." Medicaid has helped Dashita cover the costs of her HIV treatment, and address her other disabilities – but it became ever more critical when she discovered that she was pregnant.

As a young soon to be mother, Dashita had a lot of questions about pregnancy in general and what that process would entail. Also as a person living with HIV, she was worried about potentially transmitting HIV to her son. Dashita's provider told her she needed to change her medication to prevent HIV transmission to her son. Medicaid covered the costs of her new HIV medication and Dashita gave birth to a healthy baby boy, who was born HIV-negative.

My income was already so low and losing the income was scary because I worried how to pay for the medical care I needed so I can go back to work. Having Medicaid made all the difference. I am recovering now and should soon be able to go back to work."

"As a Registered Nurse that works in hospice and that has previously worked in cardiac care, Medicaid has been beneficial to my life and those around me personally and professionally. At the start of the Covid pandemic in 2020, I was laid off from my job at a cardiologist office. I was the Nurse that managed multiple patients' blood thinner regimens. Visits were no longer done in person so I was ultimately let go and had to collect unemployment. With losing my job, I also lost my healthcare coverage. My husband works as a small business owner so he did not have coverage and could not cover our family at the time. Medicaid was what we used for our then one and two year-old daughters. The benefits were amazing as I was able to get them in to see their doctors as needed.

Currently, I work as a Hospital Liaison for a hospice company and help families get their loved ones home with hospice or to a hospice house every day. The hospice benefit is covered under Medicaid and Medicare primarily. Thousands of families benefit from end of life care for their loved ones every year, and without it many would be left lost without the guidance of hospice - free of out of pocket costs.

I see the families that are completely overwhelmed with the care and don't exactly know what to do to ensure their loved ones are comfortable and safe. Hospice does exactly that. To add an additional cost for grieving families for hospice care is exactly what we as Americans and good humans don't need. Please PROTECT Medicaid, as it covers the healthcare of so many and adds an extra layer of comfort to all families- big and small, rich or poor."

"Receiving these benefits is a huge relief for me. Without them, I honestly feel like I'd be stuck. expansion, my patient's only qualified for family planning which provided them with condoms only. Then due to the implementation of the Affordable Care Act these individuals were able to secure health insurance but lacked the understanding of how these plans worked for their specific situations. They were often left with out-of-pocket expenses that they could not afford to pay and tax complications that put them in hot-water with the IRS.

The gift to the formerly incarcerated is The Medicaid Expansion Program! The formerly incarcerated are now able to stabilize and manage their health without the worries of ""how am I going to pay the doctor or the pharmacy for my medication"". As a Community Health Worker, I have witnessed my patient's thrive in their lives after incarceration due to being able to establish care with a physician, have visits with specialty providers, get their medications, durable medical equipment, eye glasses and attend dental appointments! My motto is this: not everyone is looking for a hand-out, they're looking for a hand-up! The Medicaid Expansion Program is that ""hand-up"" for the formerly incarcerated individuals transitioning back into society!"



In 2013, Penny was diagnosed with breast cancer and was able to get treatment through Breast and Cervical Medicaid. However, on the last day of her radiation treatment, she lost her coverage, and her oncologist



wouldn't see her because she was uninsured.

That was not the end of Penny's medical troubles, as she later suffered an aneurysm, lost her vision, and lived in fear of her breast cancer returning. Forced to deal with all of these health issues while trying to navigate our health system without insurance was scary and stressful. Penny worried about how she would afford care, and eventually owed tens of thousands of dollars in medical bills. Not having health coverage didn't just impact her, it impacted her family and loved ones as well. Penny's life changed for the better on December 1, 2023 when she was finally able to get health coverage again through the North Carolina Medicaid Expansion program.

Having health coverage this last year has vastly improved Penny's life. She is able to get her diagnostic mammograms and other preventative screenings without going further into debt, and when she got a dangerous tooth abscess, she was able to get that taken care of and focus on healing.

Last year, North Carolina took an important step forward in making sure that every person in our state could get the healthcare they need without fear of going broke. Medicaid and Medicaid expansion save lives, protect families from medical debt, and create a healthier and more productive community. Please protect this program at all costs.

S, a 46 year old single man, has struggled to access disability benefits due to his limited medical records. In 2013, S left full-time employment to take care of his elderly mother until her passing. Falling within the coverage gap, and being unemployed, S lost access to affordable healthcare.

Following his mother's death in 2018, S struggled to manage his depression and chronic pain. Everything changed for S when North Carolina passed Medicaid expansion in December of 2023. S immediately scheduled appointments to establish a healthcare plan to obtain the diagnoses he had been desperately needing. As a result of Medicaid Expansion, S has been able to establish a health plan; reduce his risk of morbid obesity; complete multiple rounds of physical therapy to improve his pain; and obtain mental health services and diagnoses.

Without Medicaid, the costs would be overwhelming. Emergency room visits, pharmacy bills, even basic care like eye exams and dental treatments everything would become a financial burden. I wouldn't be able to afford eyeglasses, prescriptions, or even necessary medications that can cost \$200 to \$300 each. With the way the economy is, and the low wages many people are paid, those costs are simply unaffordable. When you have to choose between paying for rent, utilities, or medical care, most people will choose to keep a roof over their head. This is why we have so many health crises—people are forced to choose between their health and paying their bills.

Medicaid helps make it possible to balance both, easing that financial stress and allowing people to take care of their health. Cutting Medicaid would be devastating to those of us who need it, especially since private health care is out of reach. Private insurance can cost \$2,000 to \$3,000 a month, which is completely unaffordable for most people. With minimum wage hovering around \$7.25 an hour, even a job that pays \$12 to \$15 an hour isn't enough to cover rent, utilities, and medical expenses.

Without Medicaid, we're left with impossible choices, and the health of many people would suffer.

Medicaid, as part of the dual program with Medicare, is critical to my health and well-being, especially as a senior who needs these services. Without it, I wouldn't have access to the care I need. If Medicaid were cut, I would lose access to so many essential services, including the care for my glaucoma. If I don't receive proper treatment, glaucoma could lead to blindness. That's a terrifying



possibility for me. There are also other services I depend on that I wouldn't be able to afford without Medicaid's support. Medicaid makes it possible for me to live my life with the care I need during my golden years."

called spinal stenosis, for which his doctor prescribed pain pills. Unfortunately he was one of the millions of Americans who ended up getting addicted to those pills which led to incarceration., in large part due to the fact that he couldn't get the medical treatment he needed.

Medicaid has really saved his life. It has allowed him to get addiction and other medical treatments and allowed him to get his prescriptions. He can now get the proper health care he has been needing. He is able to have c pap machine which he could never afford.

He is very grateful to have health coverage through the Medicaid expansion program, as it has allowed him a second chance at life. He is now training to be a peer counselor to help other people suffering from substance use disorder.

Auna is also a therapist and understands the importance of Medicaid coverage for people suffering from mental health issues and substance use disorder. Being able to access critical services gives people that are struggling a fighting chance.

DeAnna represents many in the sandwich generation - she spent most of her time caregiving for her daughter while also caring for her own aging parents. DeAnna still steps in to help her daughter when she needs additional assistance or backup with her own kids.

Over the past few years DeAnna increasingly found herself managing her own health problems – mobility challenges leaving her in need of a hip replacement, a hospitalization for a gluten sensitivity, thyroid issues, and debilitating fatigue. A blood draw revealed abnormally high protein in her blood, and after months of additional testing she was diagnosed with Multiple Myeloma in August 2022.

Between twice-weekly chemo treatments and the side effects of the medication, working a job that would provide health insurance is out of the question. Charity care provided through the hospital helped cover her chemotherapy but would not cover the stem cell transplant she needed. Multiple Myeloma is not curable, and without the transplant, she was only given a few years to live.

She stayed on chemotherapy while fighting an appeal for Social Security disability benefits and became an advocate to expand Medicaid in North Carolina. After a year, and just before Medicaid expansion went into effect that could have provided her the coverage she needed, DeAnna finally won her appeal. Within a few months she was able to receive her stem cell transplant.

Without Medicaid, DeAnna's family wouldn't have much time left with her. With Medicaid, she is able to receive her maintenance chemotherapy to keep her in remission for as long as possible."

"Miles requires quite a bit of hands-on care. He is not able to do any tasks to take care of himself, so just simple things like brushing his teeth... he requires 24-hour-a-day care," his mother, Mary Mac, explains.

Medicaid provides essential services and supplies that private insurance doesn't cover. These services allow his parents to rest at night, knowing that a nurse is monitoring his ventilator, tracking his vital signs, and administering medications. Without this support, Mary Mac and her husband would be awake 24 hours a day, an impossible burden.

But Medicaid does more than provide medical care. It allows Miles to be a child.

He loves school, where he uses a communication device to connect with his teachers and classmates. "School enriches his life so much. He has such a close relationship with his teachers and therapists, and he wouldn't be able to attend without a nurse to accompany him," Mary Mac says. Thanks to Medicaid, Miles can also leave home safely, whether it's for doctor's appointments, a trip to the museum, or simply spending time in his community. Medicaid helped his family purchase an accessible van, a necessity for Miles to be able to leave his home.

The thought of losing these services is terrifying for families like Miles'. "Medicaid is what allows Miles to have that hands-on nursing care. It is what allows us to make our home and vehicle accessible for Miles. Those services are what make it possible for Miles to attend school," Mary Mac says.

If Medicaid funding were cut, the family would face an unthinkable decision: placing Miles in a facility. "We just cannot imagine that for Miles – the utter sadness it would cause him to be ripped away from his family... It would be absolutely devastating."

Not only would Miles lose the love and support of his home, but his health could suffer dramatically. "With the staffing ratios in facilities, his health could decline severely. These services have kept him healthy and out of the ICU. He's had just one hospital admission in the past nine years."

Miles is more than his medical needs. He is a smart, kind, and aware child who deserves to grow up in a loving home. He deserves to learn, to play, and to be with his siblings.

"Medicaid matters because it allows our son Miles to stay home and grow up with his family. Medicaid matters because it provides the hands-on nursing care that Miles needs just to live every day," Mary Mac says."

"I live with my 74 year old grandmother, Beth who broke her leg in August. Had she not had Medicaid, it would have crippled her financially, on top of already being crippled physically at the age of 74. She is a staunch Republican and voted not only a red ticket in NC, but also nationally as well. Please look out for your constituents and do not defund Medicaid. Millions, like Beth, depend on it."

"I had no health insurance for 7 years while working part time at a non-profit and taking care of my child and mother as a single parent. I got cancer. At the time I was finding Down Home NC, which placed ads on Facebook about Medicaid Expansion. I worked with Down Home to help pressure lawmakers to vote for Medicaid Expansion. Meanwhile, I was diagnosed with cancer and had to have treatment. I was referred to Novant Health, who said not to worry about the money until a week or two of my surgery. They tried to send me to Medicaid for emergency coverage. Medicaid said they wouldn't pay as it wasn't filed in a timely manner. I think both parties, Novant and Medicaid wanted to pass the buck. I waited it out as I didn't have \$24k lying around, and one of them paid for it. I think it was Novant as I never got another bill. After that, Medicaid was given to me. I called our local Social Services to find out why. They said it was probably because I had cancer and that racked up a certain amount of medical debt that triggered the coverage. My daughter was a beneficiary of the expansion as a college student. She would've had to pay \$2,000 for health coverage at college but could get a Medicaid waiver due to her income level."

"After losing health insurance coverage in January, I was informed of this loss in the waiting room of urgent care. After months of unsure waters, I am now covered by health insurance and relieved that my quality of life will soon improve as I'm able to access care and pharmaceuticals."

"We have an adult daughter with autism, an intellectual disability, and brain cancer. While she's covered under our employer health plan, it doesn't cover the daily services she needs, like her day program and in-home assistance. We're deeply concerned about how losing Medicaid would impact her chemotherapy, which is vital to prevent further tumor growth or a more aggressive cancer. As a middle-class family, we can't afford her care and out-of-pocket expenses without risking everything we've worked for."
